The quality system approval applies only to the products listed above.

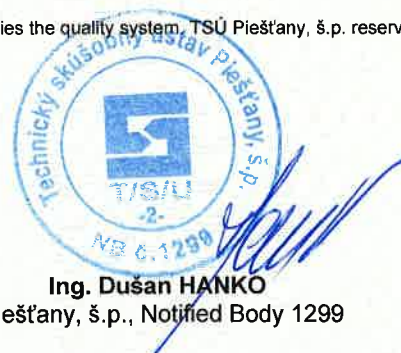
